A work programme to determine the future strategic direction of all mental health services in Devon is taking place collaboratively with all system partners as part of the Sustainability Transformation Plan. There is no confirmed date in which these services may be re-tendered at this time.

- **The contract's estimated annual value at the last point that it was tendered,**

Funding for IAPT is part of the block contract for Mental Health, Learning Disability and Older Peoples Mental Health so costs cannot be separately identified. The service has not previously been put out to tender – Livewell became the provider of these services via “Right to request” – see attached briefing note `4. Establishment of Livewell South West CIC2`.

- **Whether your current IAPT service contract is run as an AQP or block contract,**

Both providers are on block contract agreements.

- **Whether your current IAPT service have been subject to any Performance Notices,**

NHS NEW Devon CCG issued 2 Contract Performance Notice`s in 2015/16 in relation to the IAPT service provided by DPT and LWSW. These were related to Access and Recovery targets.

- **What type of system your current IAPT contract uses (i.e. IAPTus, PCmis, etc.)**

Both providers use IAPTus
